**WARRANTY**

Every Sani-Tech Refuse Compactor is thoroughly inspected and tested before leaving the factory. It is warranted to be free of defects in workmanship and materials for the period of one (1) year from the date of installation, or one (1) year and two (2) weeks from date of shipment from seller's facility, whichever comes first.

Buyer assumes all risk and loss resulting from the use of the product whether used singly or in combination with other goods. Seller neither assumes nor authorizes any person to assume for Seller, any other liability in connection with the sale or use of the product sold and there are no oral agreements or warranties affecting this agreement.

This warranty shall not apply to a product that has been repaired or altered by anyone other than the Seller or authorized Sani-Tech service center. This warranty shall not apply to any product subject to negligent use or accident, inadequate lubrication or maintenance practices, nor to any product not operated in accordance with the written instructions of Seller, or which has been operated beyond the rated capacity of the product.

The product purchased under this agreement shall be used exclusively by Buyer and by no other person and therefore there shall be no third party beneficiary to the express or implied warranties in this agreement.

Any part, which is determined by Sani-Tech to be defective in materials or workmanship, will be repaired or replaced at Sani-Tech's option. Buyer shall be responsible for any shipping costs, travel charges, and taxes pursuant to the performance of this warranty. Any performance pursuant to this warranty shall be at Sani-Tech facilities or an authorized service location as Sani-Tech designates.

Seller makes no warranty of merchantability of the expressly disclaimed. Sani-Tech's goods or fitness for a particular purpose. Sani-Tech's liability for consequential and incidental damages is liability in all events and for all purposes is limited to and shall not exceed the purchase price paid (for the product) by the Buyer.
